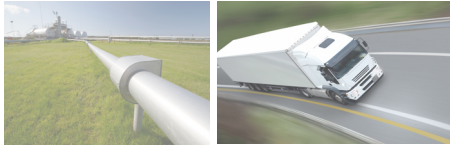

### GHG audit for a global consumer products company

Our carbon audit specialists conducted a comprehensive audit of GHG inventory data and recommended quality controls to improve the consistency of carbon calculations and protect the integrity of publicly disclosed data. An industry benchmarking analysis ensured that the company's public carbon disclosure reports met or exceeded those of its rivals.

### Carbon management program for a government agency

Our experts quantified a registry grade GHG inventory for Scope 1, 2, and 3 with over 5 million metric tons of CO<sub>2</sub> emissions. Reduction potential analysis used marginal abatement cost methodology to enable the agency to set a 28% reduction target over the next ten years.
